

IMPORTANT INFORMATION

Prerequisites:

To participate in the Lifeguarding Instructor course, individuals must be at least 17 years of age on or before the final scheduled lesson of this course. Proof of age will be required (Birth Certificate). Individuals must also successfully demonstrate the ability to perform the following swimming skills listed below. The Skills Screening is mandated by the Red Cross and is designed to determine if instructor candidates have the prerequisite knowledge and skills to take the instructor course. Possess a current American Red Cross certificate for Lifeguarding/First Aid/CPR/AED or equivalent certification from another organization. Sucessfully complete the online session.

Skills Screening:

• 300 yards continuously demonstrating breath control and rhythmic breathing. Swim using the front crawl, breaststroke, or a combination of both, but swimming on the back or side is not allowed. Swim goggles may be used.

• Tread water for two minutes using only the legs. Hands should be placed under the armpits.

• Complete a timed event within one minute, 40 seconds.

- Starting in the water, swim 20 yards. The face may be in or out of the water. Swim goggles are not allowed.
- Surface dive, feet-first or head-first, to a depth of seven to 10 feet to retrieve a 10-pound object.
- Return to the surface and swim 20 yards on the back to return to the starting point with both hands holding the object and keeping the face at or near the surface to be able to breathe. Candidates should not swim the distance under water.
- Exit the water without using a ladder or steps.
- A submerged victim rescue.

• A demonstration of how to care for a head, neck or spinal injury in deep water.

Certification & Completion Requirements:

- Successfully complete the precourse session.
- Successfully complete the online session.
- Attend and successfully participate in all course lessons.

• Successfully complete the required number of practice-teaching assignments.

• Score at least 80 percent on the 3 final instructor course written exam.
