**Purpose**: The purpose of the Highmark Blue Shield Graduate Fellowship is to recognize and support outstanding graduate students currently enrolled in the School of Public Affairs, concentrating in Health Care at Penn State Harrisburg who are candidates for a graduate degree, Masters or Doctorate of Public Administration or a Masters in Health Administration, who demonstrate strong interest and potential for success in the Health Care field, who have achieve positive academic records, and who have exhibited a strong commitment to a career in health care.

**Eligibility**: Consideration for this fellowship will be given to all full-time or part-time graduate students exhibiting academic excellence who have been admitted to Penn State Harrisburg as candidates for the following graduate degrees; Masters or Doctorate of Public Administration or Masters of Health Administration, with a concentration in health care, who demonstrate strong interest and potential for success in the Health Care field, who have achieved positive academic records, and who have exhibited a strong commitment to a career in health care.

<u>Term</u>: The fellowship will include a tuition scholarship. The number and amount of the awards are based on the amount of the available funds. This scholarship is applicable for the upcoming <u>Fall 2019 - Spring 2020</u> academic year only. Scholarships are not transferable to other semesters. Any remaining funds revert back to the scholarship fund. Funding is applied directly to the awardee's 2019-20 PSU tuition account.
