# Denise Thompson (Class of 2010)

Denise is an assistant professor at the John Jay College of the City University of New York. She received the inaugural Jeremy Collymore Award for Research in Humanitarian Response and Disaster Risk Management last year. The award was presented during the 10th Caribbean Conference on Comprehensive Disaster Management on December 8th, 2017 at the Melia Nassau Beach Resort, in The Bahamas. She was awarded a US\$5,000 research grant to support her research in the area of strengthening the disaster logistics supply chain the Caribbean. The research will examine the complexity of logistics coordination to deliver relief supplies, the emerging contingencies on many of the islands once a disaster strikes, and pressures on the transportation systems which have continued to overwhelm the regional response systems. The Collymore Award supports

innovative and insightful research for improved emergency response and Disaster Risk Management (DRM) in any of the eighteen (18) Participating States of the Caribbean Disaster Emergency Management Agency (CDEMA). The Award is a tribute to Mr. Jeremy Collymore in recognition of his outstanding and sterling contribution to the CDEMA system and to disaster risk management in the Caribbean region and beyond. The Award was co-sponsored by Profiles Caribbean Inc.

# THE 79<sup>TH</sup> ANNUAL CONFERENCE OF AMERICAN SOCIETY FOR PUBLIC ADMINISTRATION (ASPA)

The 2018 annual ASPA conference was held in Denver for five days from March 9 to 13. The ASPA conference is one of the biggest conferences in the field of public administration. Its mission is to advance excellence in public service. This year's conference theme was *Mission Focused and Service First: Creating Innovative Solutions*.

Four PADSO members – Eunsil, Glenn, Huiting, and Joseph – presented their research at the conference (see details above). The presentation experiences provided valuable opportunities for we doctoral students to develop their research by sharing their ideas with scholars and practitioners and receiving feedback. PADSO members were able to obtain a competitive travel grant from the Penn State Harrisburg Student Government Association (SGA) and travel assistance from the School of Public Affairs.



PADSO members also assisted with operating the Penn State Harrisburg School of Public Affairs exhibitor booth. This afforded members the opportunity to give back to the school by being able to explain their experiences in the doctoral program to potentially interested students, as well as speak to the other programs (both residential and online) that the School of Public Affairs has to offer.

# THE 8<sup>TH</sup> ANNUAL NORTHEAST CONFERENCE ON PUBLIC ADMINISTRATION (NECOPA)

The NECoPA Conference is the annual regional conference of ASPA and is intended to provide educational opportunities for scholars (faculty and students), practitioners (administrators and policymakers), and others interested in public service in a collaborative environment by educating the general public and members of the organization on current issues, research, and practice in public and nonprofit organizations. The 2017 conference was held at the University of Vermont. 

Moreover, the 13<sup>th</sup> Annual Student Symposium was held in April 18-20, 2010 at Penn State Harrisburg. **Eunsil Yoo** participated in both events with her research, *A Study of Important Elements in Collaborative governance*.

Eunsil presented a literature review study that examined how important elements of collaborative governance are different depending on the network research in public administration. She also showed the evolution of


